TO: **"Redstone Resort Ltd" and their respective directors, officers, shareholders, employees, instructors, agents, volunteers, independent contractors, subcontractors, representatives, sponsors, successors and assigns (hereinafter collectively referred to as "the RELEASEES").**

DEFINITION:

In this Release Agreement the term "Golfing" includes use of all Redstone Resort Ltd. golf facilities, including, without limitation, fairways, greens, driving range, Club House, restaurant, parking lot ("the Facilities") and rental and use of golf equipment and power carts and push carts ("the Equipment") and all other activities including involvement as a participant or spectator at group events, clinics, lessons, golf rounds, golf practice, tournaments and competitions which take place at the Golf Course and Facilities.

ASSUMPTION OF RISKS:

I am aware that Golfing involves many risks, dangers and hazards including, but not limited to wind; falling trees; mountain golf course terrain hazards; wildfire; slips and falls; being hit by stray golf balls or golf clubs; accidents or collisions involving motorized or push golf carts; lightning strikes; encounters with domestic or wild animals; Coronavirus or Covid19 and its variants; failure to act safely or within one's own ability or to stay within designated areas; negligence of other persons; and NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THESE RISKS, DANGERS AND HAZARDS. I FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGERS & HAZARDS ASSOCIATED WITH THE USE OF THE FACILITIES AND OR EQUIPMENT. RENTAL EQUIPMENT AGREEMENT:

1. I accept full responsibility for the care of any power cart or rental clubs that I use (the "Equipment") and I agree to pay for any damage to the Equipment and replace at full retail value any Equipment not returned or damaged at the completion of the round up to a maximum of \$9000 for the golf cart. **2. I am familiar with the proper use of the equipment. I understand that the rental staff can answer questions I may have as to the proper use of the equipment.**

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT: In consideration of the Releasees permitting my use of the Facilities and or rental of the Equipment I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Releasees and TO RELEASE THE RELEASEES from any and all liability for any damage, expense or injury including death that I may suffer, or that my next of kin may suffer, as a result of my use of or presence on the Facilities or my use of the Equipment DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF STATUTORY DUTY OF CARE, INCLUDING ANY DUTY OWED UNDER **THE OCCUPIERS LIABILITY ACT**, R.S.B.C. 1996, c.337, and amendments thereto in respect of the selection or maintenance of the Equipment or in respect of the provision or failure to provide any warnings, directions or instructions as to the use of the Equipment or the risks, dangers and hazards of Golfing I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE;

2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from all liability for any damage to or loss of property of or personal injury to any third party.
3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity.

4. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia and no other jurisdiction, and
5. Any litigation involving the parties to this Release Agreement shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia.
